September 12, 2023

The Chapter Board had a lengthy meeting earlier this month. Our **Chapter Advisors** had several important items to share. Tara initiated a discussion on the use of Facebook as a tool to reach members of the public we may not be currently reaching. **Communications Chair Alice Stieve** agreed to call the committee together to consider this. **Wendy** reported that her counties will have **Hazardous Waste Collections** soon: Westmoreland on September 30 and Richmond County on October 21. **Tara** shared that all four Northern Neck counties are taking registrations for

household water quality testing through Virginia Tech. The cost is \$65 for a very thorough analysis of homeowners' drinking water. Contact county extension offices for more details.

Tara and Wendy issued an appeal for NNMNs to work at the **State Fair at the VA Cooperative Extension display**. An email blast with all details followed. Please contact them if you want to enjoy time at the Fair and help represent VCE.

President Paula announced that the 5-year financial review was completed. Fran Westbrook, treasurer of the Master Gardeners, handled the task and reported that she "found the financial records of the Northern Neck Chapter of the Virginia Master Naturalists to be financially accurate." Great news, Paula and Debby!

Vice President Polly has an October 12 program arranged at Lancaster Community Library. Doug Dwoyer, a Middle Peninsula Master Naturalist, will talk on "The Anthropocene Naturalist". Time TBD. In January, Dr. John Swaddle from the College of William & Mary will provide a program on bird strikes.

Diversity & Inclusion Chair Ellen Hunter reported that NNMN members have been enthusiastically working with Emmanuel Christian Fellowship in Richmond County to create nature trails through their wooded property. This is a predominantly African American congregation. The group also requested assistance with plant identification on site and information about native plant species. Work will continue with this group.

It is hoped that the November program with members of the **Rappahannock Tribe** will develop relationships for future collaborations.



A new location for the stewardship activity, "Clean Northern Neck Waterways", was approved by the Board. The chapter will "adopt a highway", which will be a 2-mile stretch of Balls Neck Road from Shiloh School Road to Hughlett Point. Two clean-ups are required each year, and after the second cleanup the highway department will erect a sign naming NNMN as the adopter. Email blasts will give the dates and times of these clean-ups.

The Outreach Committee has had a busy and enjoyable season. Many NNMN volunteers have manned the various booths, providing positive and friendly comments and advice to members of the community. THANK YOU to all who have been a part of the 2023 outreach effort!
