September Chapter Meetings Those of us who attended the Chapter meetings on September 13 were not disappointed! We were in a great venue: the Lodge at Cat Point Creek. Although the area is not yet open to the public (that will happen soon), the Rappahannock River Valley National Wildlife Refuge staff made it possible for us to have our meetings and social there. The Board meeting was held at noon, followed by a brief member meeting to seek nominations for officer and committee chair positions (election is November 1) and to remind members that we will vote on the 2023 dues increase (to \$30) then as well. Next, Steve Colangelo (President of the Refuge Friends) and Marcie Kapsch (new Refuge Director) shared the projects in which our chapter volunteers could be significantly involved. Those include flora and fauna inventories, development of a new native garden, maintenance of existing native gardens, and development of educational activities for the public (including youth). More details will be forthcoming. Eric Hentges (ericjhentges@gmail.com) will act as the Chapter point person for our Refuge work. Following the presentation, members socialized with Steve, Marcie, and each other over snacks and cookies. Some members also visited the dock and boat launch on Cat Point Creek, which are both substantial facilities. Chapter Advisors From Tara:

Lancaster and Northumberland County Virginia Cooperative Extension offices will be offering household well water testing in a drive thru format this October. Participants will pick up their water sampling kit and instructions at the extension office, and return it to the same location for processing by the labs at Virginia Tech. The cost is \$65 and tests include results on 14 parameters (iron, manganese, sulfate, hardness, sodium, copper, nitrate, arsenic, fluoride, pH, total dissolved solids, coliform bacteria, E. coli bacteria, and lead. Results will be emailed or mailed to participants approximately 4-6 weeks after the testing. Test kits must be picked up on October 3 in Northumberland County and October 4 in Lancaster County. Drop off of water samples will be on October 5 in both counties. Pre-registration and pre-payment are required.

To register, call 462-5780 in Lancaster County and 580-5694 in Northumberland County. The number of tests available is limited, so register early!
